

## **Wakefield Park Online Entry Forms Introduction**

Wakefield Park Motorsport publishes or makes available on the Wakefield Park Motorsport website, information, advertisements, product and service offers and links supplied by Wakefield Park Motorsport and third parties (Material).

Use of this Online Entry Forms service is a Wakefield Park Motorsport authorized third party provided service.

### **Personal and Non Commercial Use Only**

Use of the Wakefield Park Motorsport online services is for your personal and non-commercial use only. Except for the Material held in your computers cache or a single permanent copy of the Material for your personal use. You must not, without the explicit written approval of Wakefield Park Motorsport or the authorized third party provider:

- modify, copy, distribute, transmit, display, perform, reproduce, publish or license any Material;

- Entry Fee: All categories include an applicable entry fee, which may vary according to the event organisers or category type.
- All prices displayed include GST.
- The organisers reserve the right to accept or reject entries at their sole discretion without assigning reason, in accordance with the NCR's.
- Provided the competitor has notified the withdrawal in writing seven days prior to the meeting, the entry fee, less a \$50 administration fee, will be credited.
- Payment can be made by either credit card or cheque. For the purpose of payment by cheque, competitors will not be considered entered until full payment of all applicable fees as per details received via the online entry submission, including Entry Fees, Administration Fee and Garaging Fees (where applicable), are cleared funds.
- A fee of \$50.00 will be charged for any cheque that is dishonoured.

- If entry forms are not completed correctly, or information is either inaccurate or misleading, funds may be returned and entry will not be accepted until correct information is received.
